PRE-DEPARTURE CHECKLIST

1 YEAR - 6 MONTHS BEFORE DEPARTURE

Renew passport if needed **Brainstorm Destinations** Begin applying for jobs / setting up your business to be fully remote Begin Apartment/Home Hunt and Research decide if you will rent / sell / give up your apartment/ home and

3-4 MONTHS BEFORE DEPARTURE

discuss with landlord or make listings

- finalise destination and apply for any needed visas and tax codes
- set up international/multi-currency bank account we recommend WISE
- Lock in housing situation (at least for first month!)
- do all routine doctor check ups and get extra medications as needed
- Get vaccines (if needed)
- book flights

2 MONTHS BEFORE DEPARTURE

- finalise pending jobs if applied close out any you are not accepting
- begin checklist of what you will take/sell/leave in storage
- if you work remotely-let clients know of your move & upcoming time zone change













1 MONTH BEFORE DEPARTURE

		make time for friends and family
		purchase any travel/life essentials you may need (Visit our Amazon Shop)
		arrange arrival transfers - if you have a lot of luggage you will need this!
		take things you will not need or are leaving to storage unit
		set up international phone plan on your domestic line (I use Google Fi/Voice
		purchase portable wifi device (essential for digital nomads!)
		purchase unlocked cell phone (you will need this to get a local foreign SIM)
		inform current clients of upcoming OOO travel dates (you will want time off to get settled in)
		purchase long term travel insurance (We recommend World Nomads)

		reconfirm arrivals with new landlord and transfer company
		final email reminder to clients of move and OOO dates
		Set OOO on email autoresponder
A	FT	ER ARRIVAL let your friends and family know of your arival
		set up local phone number
		purchase in destination life essentials
		finish off any in destination visa requirements *many companies require announcement of arrival
		make copies of apartment keys (if allowed/required)
		set up any local bank accounts needed
		email clients of return to office when ready

C**ONSIDER TEACHING ENGLISH ABROAD** WITH A <u>TEFL</u> AS A WAY TO GET A VISA

SAVE LOTS OF MONEY BEFORE YOU GO! MOVING IS EXPENSIVE AND INTERNATIONALLY IS NOT AN EXCEPTION

REMEMBER TO TIE UP YOUR LOOSE ENDS - CANCEL THINGS LIKE GYM MEMBERSHIPS, SUBSCRIPTION SERVICES, ETC. THAT YOU WILL NOT NEED WHILE YOU ARE ABROAD

STAY AS ORGANIZED AS POSSIBLE! WE RECOMMEND CREATING A GOOGLE FOLDER WITH ALL OF YOUR IMPORTANT INFORMATION AND DOCUMENTS AND KEEPING A SPREADSHEET OF HANDY INFORMATION

STICK TO YOUR BUDGET! IT IS EASY TO GET OVERSEAS AND IMMEDIATELY START BLOWING YOUR BUDGET BECAUSE YOU ARE EXCITED. REMEMBER THIS IS FOR THE LONG RUN, SO STICK YOUR SET BUDGET AND TRUST THE PROCESS

CONSIDER YOUR TRANSPORTATION OPTIONS - IS WHERE YOU ARE MOVING WALKABLE? WILL YOU NEED A CAR? BIKE? BUS? THIS CAN BE A DECIDING FACTOR WHERE YOU MOVE

SET UP YOUR BUSINESS IN ADVANCE - MANY "DIGITAL NOMAD" VISAS WILL REQUIRE PROOF THAT YOU ARE EARNING A LIVABLE WAGE AT EAST 1 YEAR PRIOR TO YOUR VISA APPLICATION DATE, SOME MORE. THE SOONER YOU SET UP YOUR ONLINE BUSINESS VIA REMOTE WORK OR YOUR OWN SERVICES, THE BETTER. ENSURE THIS IS TRACKABLE INCOME AND BE SURE TO DO ALL THINGS LEGALLY, NOT UNDER THE TABLE AS YOU WILL NEED PROOF
